

Subject of sale:

The subject of sale are the assortments described in the attached GLS list. (annex - GLS list with description). The GLS list will be published before 24 February on the web: www.sidg.si and on the web platform <https://www.s-procurement.si/>.

The public auction is a public sale of forest timber assortment (GLS) where the sales contract is concluded with the tenderer offering the highest price for each assortment. The buyer submits a tender in **EUR/m³** for an individual lot, which are described in the attached GLS list.

Deposit:

Each interested tenderer is obliged to pay a deposit to confirm the seriousness of the bidding intention, in the amount specified below, which also functions as a condition for participation in the auction itself. The tenderer is obliged to pay this deposit before the start of the public auction, namely by **1st March 2022** at the latest to the seller's business account no. SI56 0292 2026 1894 466 at NLB d.d., reference: **231001-1-2022**.

The required amount of the deposit must be visible on the seller's account from 1st March 2022 at 4 PM at the latest.

The statement of timely deposit payments is prepared by the seller in the form of a statement of turnover on the business account of SiDG d.o.o. at NLB d.d.

The deposit for public auction goods is:

EUR 1.000

By paying the required deposit on time, the bidder has undertaken to register as an auctioneer on the S- Procurement platform and to participate in or bid for the public auction. If the bidder pays the deposit and does not register as an auctioneer or does not accede to the auction, the deposit is **not returned**.

If the deposit is paid in an insufficient amount or is paid late, the tenderer who paid it has no right to participate in the public auction as a tenderer or bidder.

The paid deposit is returned within 8 days to those bidders who failed with the bidding or who paid an insufficient amount or is paid late.

The deposit paid by the successful bidder (buyer of public auction goods) is included in the purchase price.

Conclusion of the sales contract:

Upon completion of the public auction, the sales contract is concluded with the tenderer who, in accordance with the provisions of this publication, is the buyer of the public auction goods (further: the buyer) no later than 10 (ten) days after the closing of the public auction, if this tenderer does not conclude the contract for reasons on its part, SiDG d.o.o. gets to keep the paid deposit. By paying the deposit, the tenderer explicitly agrees that SiDG d.o.o., in the event referred to in this paragraph, keeps the received deposit. In doing so, SiDG d.o.o. has the right to claim compensation in excess of the amount of the retained deposit.

The sales contract is concluded according to a sample, which in essential elements may not deviate from the sales contract sample, as prepared by SiDG d.o.o. in accordance with the applicable Rules of the company Slovenski državni gozdovi d.o.o. on the manner and criteria for the sale of forest timber assortments, adopted by the Government of the Republic of Slovenia, published and available on the website of SiDG d.o.o.: www.sidg.si and annexed to this publication.

The purchase price must be paid no later than 3 days after the conclusion of the sales contract based on pro-forma invoice. If there are reasonable circumstances on the part of the buyer that he would not be able to settle the purchase price within a specified period of 3 days after the conclusion of the contract, the seller will be informed in writing, immediately and before the expiry of the 3 days deadline for payment under the contract, and the seller will determine whether the circumstances stated by the buyer are justified and, exceptionally, extend the deadline for payment. The new deadline will be set by the seller according to the circumstances stated by the buyer, but will not be longer than 10 days. The purchase price must be paid in full. Payment of the purchase price within the stated deadline is an essential component of the sales contract.

BUYER STATEMENT:

By signing and stamping, we confirm that we agree with the terms of sale and that we will collect the GLS, for which we submitted the tender. The tender obliges us to pay a contribution for the transport costs to the warehouse in the amount of 15 EUR/m³ and that any purchased GLS will be paid for and taken away according to the contract.
The legal representative is fully responsible for the submission of every bid.

Public auction goods become the property of the buyer only after full payment of the purchase price.

SIDG d.o.o. is obliged to ensure the receipt of the purchased public auction goods by the buyer immediately after it becomes the property of the buyer, as specified in the previous paragraph. The buyer is obliged to take over the goods of the public auction no later than the deadline set for each lot, after which the goods become his property, otherwise he is obliged to pay the cost of storage in the amount of 0.01 EUR/m³ + VAT for each day of delay, with which the bidder who paid the deposit, expressly agrees.

The buyer is obliged to remove the wood in 10 days after full payment of the purchase price.

Method of submission of tenders:

This auction is taking place online on the web platform: <https://www.s-procurement.si/>. **The user manual for implementation of the auction for bidders is annexed to this tender.**

All interested public may participate in the public auction and a record is kept of the public auction.

Only a tenderer who:

- has paid a security deposit in accordance with the requirements of this publication,
- has registered itself in accordance with the requirements of this publication.

Before the beginning of the auction, the commission proofs the registration of bidders and deposits.

Other conditions, or additional information:

The sale of public auction goods is carried out according to the system 'bought-as-seen' and the buyer has no right to a complaint related to the quality, type or quantity of the purchased goods.

The public auction is conducted by a three-member commission, appointed by SIDG.

Participants in the public auction will be notified of the results via e-mail within 3 days of the opening of tenders. The minutes shall contain the information on the decision of the selected bids.
